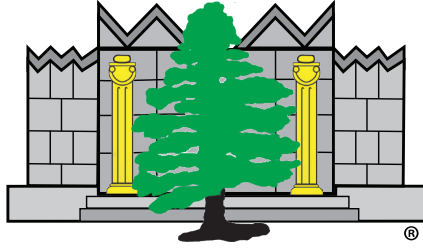

Greetings Brothers and Fellow Sidonians,

At our Mid-Winter Conference in Gettysburg, I said that I want to concentrate on a few key areas in 2020. We need to strengthen our means and frequency of communications. We need to improve our public relations. We need to grow the size of the kingdom; both in overall membership and in the number of Forests.

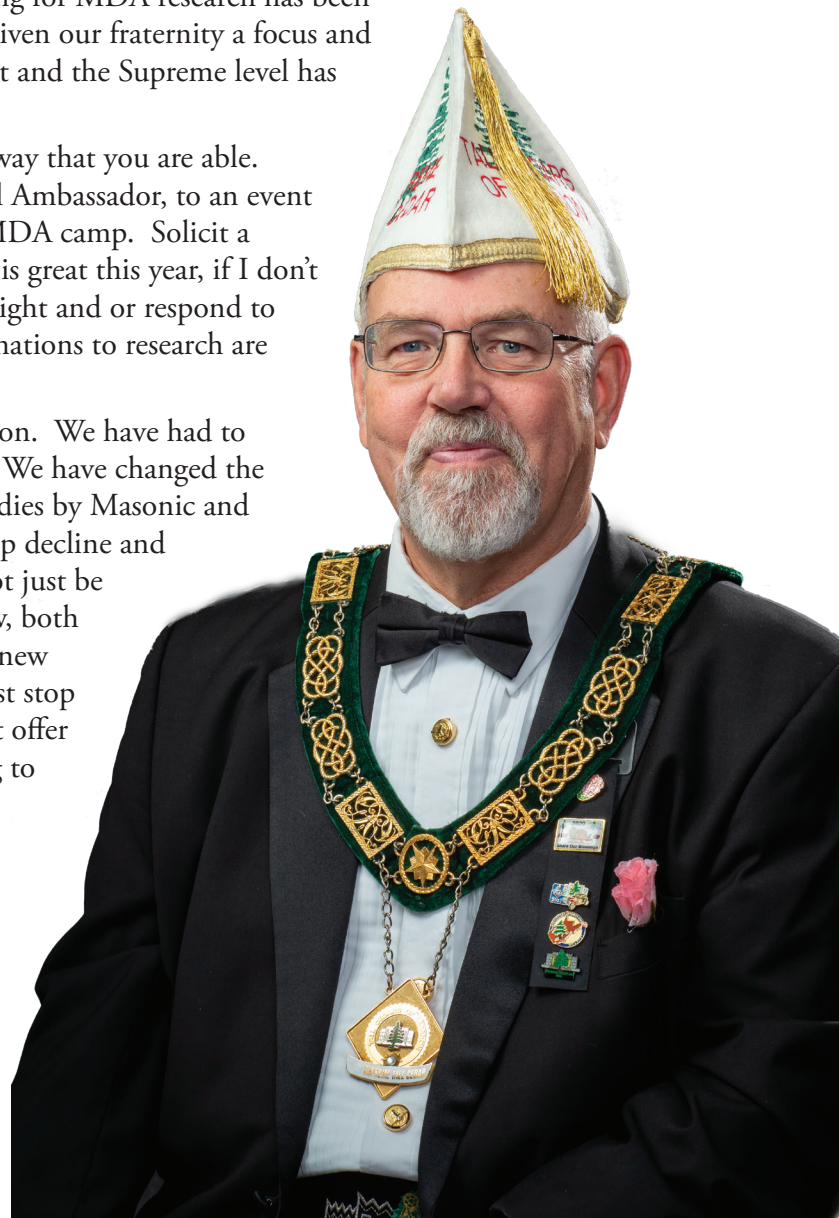

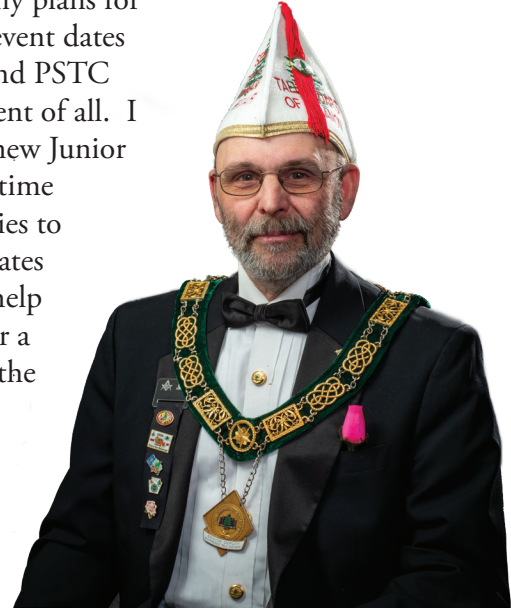


Senior Deputy Supreme Tall Cedar, J. Eric Becker, PGTC No. 13

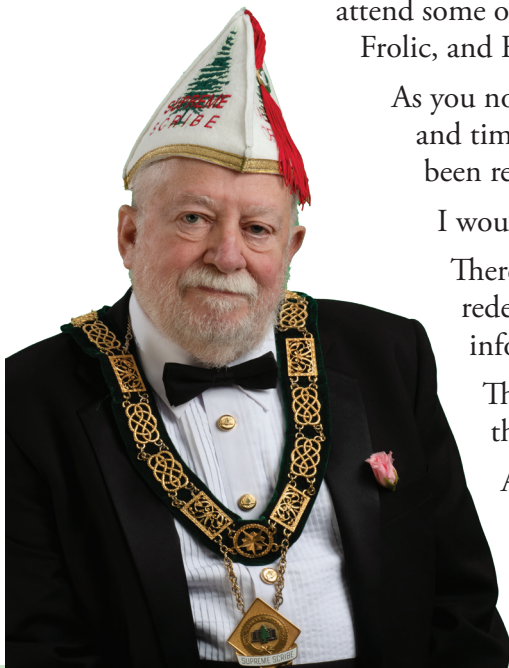

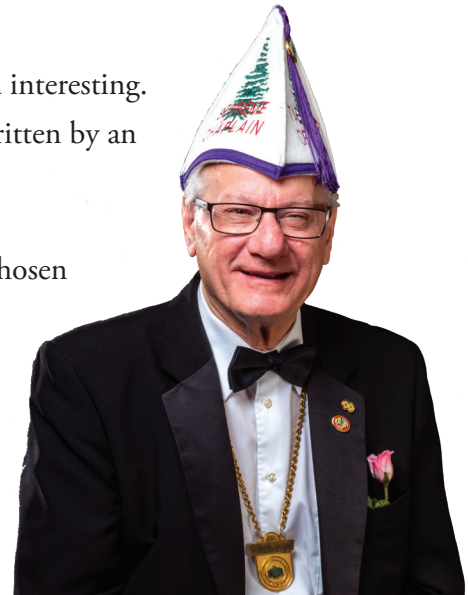

Duchenne muscular dystrophy (DMD) is the most common form of muscular dystrophy. It is a genetic disorder characterized by progressive weakness and degeneration of the skeletal muscles that control movement.

Duchenne affects approximately **1 in 5,000 live male births**. It is estimated that about **20,000 children are diagnosed** with Duchenne globally each year.

DMD is classified as a dystrophinopathy, a **muscle disease** that results from the **deficiency of a protein called dystrophin**.

There is no cure for DMD, but medications and therapy can help manage some symptoms and potentially slow the course of the disease. DMD is one of ten muscular dystrophies in focus by MDA. As our charitable goal of the Tall Cedars of Lebanon we strive to provide funds for the research to eliminate this and all muscular dystrophies.

Those with neuromuscular diseases need your help. Help in the way of donations from Rose programs, muscle walks, Night Out dinners, charitable donations, and estate planning gifts.

Communication is key. As we attend our Forest meetings and the many other Lodge and Appendant bodies, we need to emphasize the need for help. Local newspapers, television, and radio stations are a resource for getting out the word. Social media in many forms is a modern method of communication. Take the time to talk to someone about muscular dystrophy. I'll be talking to you through further communications and educational summaries of more MDs in the coming months.

Note

To be nominated from the floor, Article VII, A, 3 of the Supreme Forest Constitution reads as follows:

A candidate may be nominated from the floor at the Annual Meeting at the time other nominations previously announced are made, provided a petition is filed with the Supreme Scribe, bearing the signatures of at least five (5) members of the Supreme Forest from each of four (4) districts in one (1) region; except, in those situations where less than four (4) districts compose a region, such petition shall contain five (5) signatures from each district composing such a region.

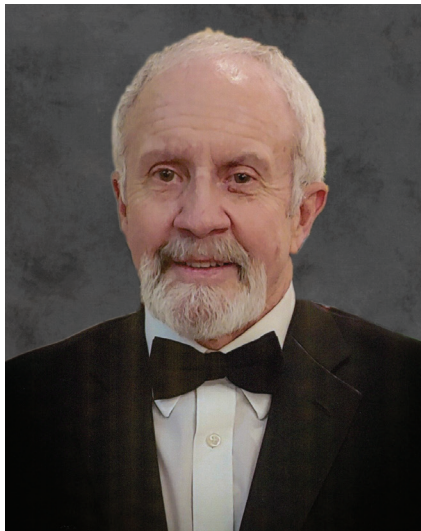

2020 Annual Meeting and Convention Postponement



Fellow Cedars,

Based on the continuing health crisis that we face as a nation, and the concerns that I and the officers of the Tall Cedars have for the safety of our members, I have decided to postpone the 2020 Annual Meeting and Convention that was to be held in Wildwood, NJ the second weekend in May. 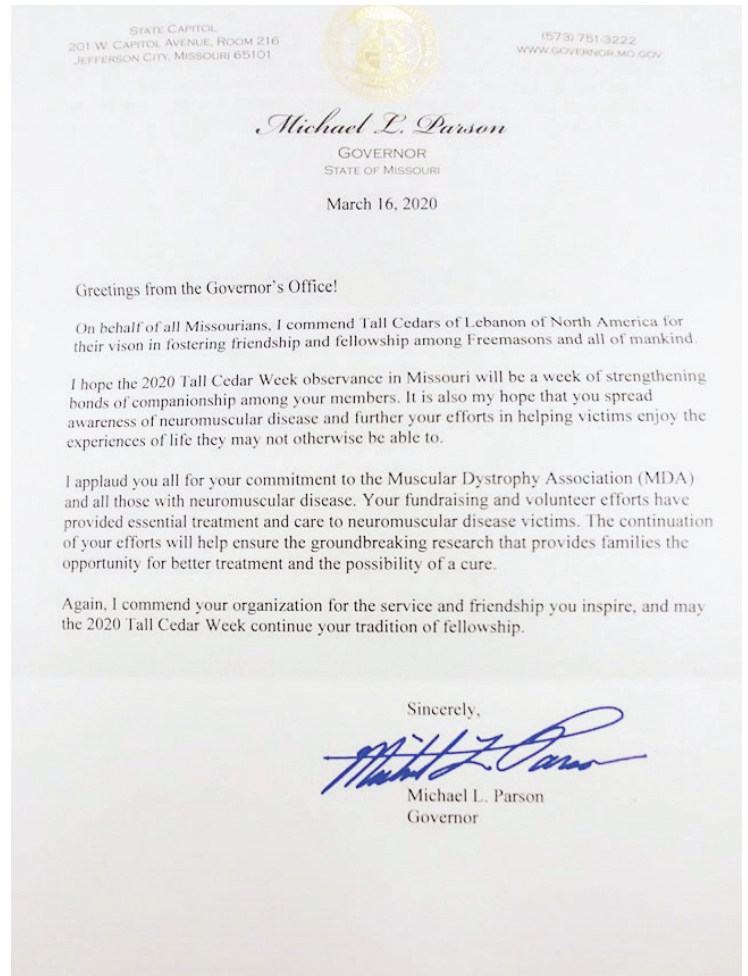

Wishes for Drew



On February 14, 2019, Valentine's Day, Steve and Vanessa Gunther received word that their seven-year-old son, Drew was diagnosed with a rare form of Muscular Dystrophy. Duchenne Muscular Dystrophy (DMD) is a degenerative muscle wasting disease for which there is currently no cure. A diagnosis of DMD typically means being confined to a wheelchair by the early teen years and eventual breathing and heart issues. As one might expect that sort of news will traumatize a young family. Drew's Grandmother, Deborah Brown immediately went to work seeking help to cure her young grandson who, along with his parents and sister Brea live in suburban Harrisburg.

Our Grand Tall Cedar, Russ Urffer gathered a committee of three additional Tall Cedars to meet with the family to assess the situation. The Cedars involved were Mark Brumaghim, PSTC, Jim Walmer, Tall Cedar Foundation Director for Region 3 and Gerry Bucko, PGTC and MDA Chairman for Harrisburg Forest No. 43. As a result, Harrisburg Forest No. 43 has adopted Drew as our MDA Ambassador.

Experimental therapies and drugs which show promise in treating DMD are not typically covered by insurance, and if a family is unable to afford to attend the trial or pay for the therapy, they are potentially missing out on life changing treatments. For their child.

Drew's medical expenses run about \$70,000 annually. Drew's father is a lawyer in Harrisburg specializing in employment law. Vanessa is a stay at home mother who must home school Drew because of his illness. Steve and Vanessa do their own fund raising through Wishes for Drew. Vanessa makes and sells special beaded jewelry and both seek funds from any source. Last November the Harrisburg Cedarettes contributed \$500 towards Drew's medical care and invited the Gunther family to be their guests at their December 3rd dinner meeting. At that time our Forest made available two pieces of equipment vital to Drew's care. One was a Maclaren Major Elite Transport Chair designed for special needs children. The second item is an Intellect Transport Ultrasound Unit and carry bag.

Many of us have met Drew and know that he is a happy, loving, energetic and funny little boy who brings joy to the Gunther family. His family must raise funds to meet Drew's medical expenses and they do so under the banner of Wishes For Drew. It is called Wishes for Drew because we all hope, pray and wish for a cure to Drew's condition. It is also called Wishes for Drew because of his fascination with blowing dandelion petals into the wind and making wishes on them. One day in particular, as Drew was looking over a field with dandelions ripe for a then 4-year-old boy to spread into the wind, he turned and said, "Mom, just look at all those wishes out there". Drew has many wishes right now; to run as fast as his friends, to be able to walk up and down the steps without difficulty, and to not get tired and cramped up so easily. Drew also has many wishes for the future which he will tell anyone who will listen; what car he wants to drive, what job he wants, or what activity he looks forward to doing with his dad when he is old enough. The goal for the Gunther's is to ensure that he has the best chance possible to realize as many of his dreams as possible.

Vanessa crafts beautiful beaded jewelry. She sells her products at every opportunity. The profits from her sales go to help cover Drew's medical care. Our Forest sponsored Vanessa and her mother, Deborah as vendors at our recent Mid-Winter conference in Gettysburg. They were able to sell nearly \$1,000 of handmade jewelry. Our Forest will continue to assist the Gunther family at every opportunity. They are planning on attending our annual convention in Wildwood, NJ as vendors and again, we will underwrite their expenses so that they can maximize the profits that will go to care for Drew.

There is no better evidence of the difference we can make than the heart-felt gratitude of a mother for the modest help we have been able to provide for her son. It is my hope as Grand Tall Cedar to continue to provide additional support to Drew and his family. THIS IS WHAT WE DO

Tournament Rules

1. Tournament will be conducted according to rules governing tournaments of the United States Bowling Congress, and all participants must agree to be so governed.
2. Any applicant who has been refused membership in the United States Bowling Congress for good and sufficient reason is not eligible to participate.
3. Teams may be made up of 4 Tall Cedars, or 3 Tall Cedars and 1 Master Mason/DeMolay, or 2 Tall Cedars and 2 Master Masons/DeMolay. Each bowler must be certified as a member in good standing by the scribe of the entrant's Forest. An entrant who is unable to bowl may be replaced by a qualified Tall Cedar in accordance with USBC regulations and these rules. Youth bowlers may not receive cash prizes however gift cards will be substituted.
4. **Beginning 2020 Cedarettes, Jobs Daughters and Masonic Youth are encouraged to register for this event.**
5. A bowler may bowl only once in each event.
6. All who bowl doubles must bowl singles and vice versa
7. Starting lanes and times will be assigned by tournament officials. All entries must bowl on lanes and at times assigned by these officers.
8. Tournament will be operated on a handicap basis of 90% of the difference between the individual average and 230 scratch.
9. A bowler's average as of January 1, 2020, must be for a total of twenty-one (21) games or more. If less than twenty-one games in a league, a bowler can add two or more leagues together to total the twenty-one games. Bowlers in more than one league must use the highest league average.
 - Average shall be certified by each entrant's league secretary.
 - Any bowler not having a league average shall be assigned an average commensurate with his ability, but not less than 150.
 - Bowlers who do not have a league average and have bowled in the Supreme Forest Bowling Tournaments, will be assigned an average compiled by averaging the last three (3) years bowled in a Supreme Forest Bowling Tournament.
10. Any bowler who reports a lower average than required, which changes his handicap classification, or who fails to report a prize of \$300.00 or more in any event in a tournament which has ended within the previous 12 month period, shall forfeit tournament entry fees and handicap prize winnings, Failure to use proper average, or to make corrections prior to completion of the first game of a series: Shall disqualify if submitted average is lower than actual average, or prize winnings will be based on submitted average if it is higher.
11. Tentative schedule of events (subject to change as required to accommodate all entrants):
 - Saturday 10:00 AM - 1:30 PM – Team, Doubles and Singles events
 - Sunday 9:00 AM - 1:00 PM – Team, Doubles and Singles events
12. Each team will indicate on entry blank preferred time for bowling. Entries from distant points will be given preference as to time whenever possible. Minor events must bowl both doubles and singles.
13. All captains must report one hour before bowling.
14. All individuals must report prior to bowling the doubles event.
15. Teams must bowl in the order names are listed on entry blank. Substitutions may be made (see rule 3), but entry blank will not be processed without team listing, including doubles and singles.
16. Tournament committee reserves all rights to govern this event.
17. An appeal or protest must be brought to the attention of the Tournament Manager within 24 hours.

A letter to the Kingdom from the Activities Committee

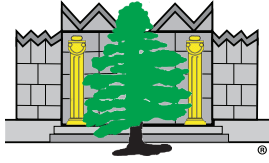

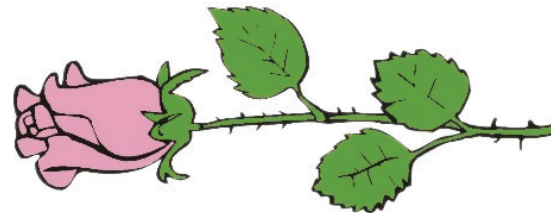
